

COMMITMENT / SUPERVISOR OF A GROUP OF YOUNG PASSENGERS

Instructions for the Supervisor of a Group of Young Passengers

Welcome onboard Tallink Silja! We wish all our passengers a pleasant stay. The purpose of the "ground rules" found below is to guarantee the comfort and safety of everyone. Please read these instructions together, before embarking on the ship!

The group + its supervisor form a team, where the supervisor is the "skipper" and represents his/her group in all matters. It is important that the supervisor knows his/her group and vice versa. The person who gives his/her consent and becomes a supervisor, should realise that it is not a mere formality but, instead, she/he shoulders a great responsibility. We thank you for your cooperation – as it will guarantee that everyone will have a nice stay onboard!

The supervisor shall:

- be at least 30 years old. A family member, when acting as a guardian/supervisor, must fulfill the age limit of the particular voyage and be at least 18 years old.
- look after his/her group during the entire voyage
- inform his/her group members that, while onboard, they have to comply with the rules of Tallink Silja rules and the instructions given by the captain
- make sure that all the group members embark on the ship together
- check that the group members do not take any alcoholic beverages, CD players, or spray paints onboard
- read the safety instructions of the ship and also tell the group members to read them
- supervise the conduct of his/her group members whilst onboard and immediately intervene in case of disturbances
- contact the ushers of the ship (via the Information Desk) whenever needed. The Information Desk is open 24 hrs a day.
- convince the group members that they are allowed to have a good time, as long as they do not disturb their fellow-passengers
- make sure that the cabins occupied by the group and the corridor outside are silent after 11 pm
- act in all situations in the best interest of the group, fellow-passengers, and the shipping company
- ensure that the minor members of the group do not partake in any alcoholic beverages
- remember that it is a punishable offence to buy and give alcoholic beverages to minors
- make the group members understand that they are liable for any damages or disturbances caused
- make the group members understand that impertinent behaviour on the part of the group, a member or the supervisor may, in the worst case, result in the group/a member or the supervisor being removed from the ship and left in the next harbour
